Solicitors Documents

DTI Documents

Even may be Police Documents giving a Reference to the Company.  
Or maybe this was Genuine

But these are ONLY Copies and there are enough ORIGINAL Documents available  
To make a 100% Opinion by anyone without self Interest.

However

In the case of the Solicitors Document

It can be shown that it was made by the forger as it had 5 signatures on and the forgers signature is crossing over one of the other signatures.

In the case of the DTI documents these are referenced  
in other signed original documents available.

So how do you get away with Basic Criminal Crime

1

You need a Police Officer friend you can call upon  
The Higher the Rank the better

Do not deny anything ever especially if the evidence is clear  
As if you do NO Police Discretion can be asked for  
by your Senior Police officer Friend

Your senior Police officer friend can then ask the Junior officer making the Investigation  
To Provide Discretion (as per Crown Rights)  
For what ever Internal Favour in Return  
In this case hold the Investigation until the developments are Delivered  
The Junior Police Officer says to the Victim and I Quote

We are the Law we Decide what is and is not a Criminal crime
